New Vice-Chairman Appointed to the AMP Board to Strengthen Its Strategic Leadership

1. The Board of Directors (BOD) of AMP Singapore has appointed Mr Hazni Aris Hazam Aris, 42, as the new Vice-Chairman of the organisation on 28 June 2019. In his new role, he will support Dr Md Badrun Nafis Saion, Chairman of AMP, in the strategic leadership of AMP. He will also assume Dr Badrun's duties in his absence.

Mr Hazni, who has been a director with the AMP BOD since 2017, will also undertake a bigger role in the Fourth National Convention of Muslim Professionals scheduled for 2022, as Co-Chairman of the Convention Steering Committee. The Steering Committee is also co-chaired by Mr Zhulkarnain Abdul Rahim, former Chairman and director of AMP.
3. On his new appointment, Mr Hazni says he looks forward to working with the staff of AMP to serve the community together. He said, "We have capable staff at AMP. I look forward to working together with them to evolve as an organisation so our services will be forward looking and ready to help our community in a fast changing and uncertain environment."
4. Mr Hazni is Assistant Vice President, Business Development, at Tokio Marine Life and is also currently serving as President of Young AMP, the youth wing of AMP.
